

## ***WildCamps Fee Structure & Payment Terms***

We've updated the WildCamps payment schedule to reflect changes in NDIS compliance. A private payment is now required to cover costs not eligible for funding—helping us continue to offer therapeutic, well-supported camp experiences for children.

### ***WildCamps Fee***

**Total Fee:** \$1,568 per participant

(This includes \$1,468 billed under NDIS and a \$100 private payment)

**Private Payment:** \$100

- Payable at time of booking through our booking platform
- Covers administrative costs, overnight staffing, resources, food, and drinks during the camp

**NDIS Portion:** \$1,468

- **Coverage:** Therapy Hours from 9 AM to 10 PM on Saturday and 6 AM to 9 AM on Sunday
- **Staffing:** One Occupational Therapist and two OT Assistants
- **Small Group Size:** Maximum of 6 children with a 1:2 therapist-to-child ratio

### ***What's Included?***

- Accommodation, meals, and all activities
- Individualised support planning, including a pre-camp consultation call with parents to discuss goals and specific needs
- Pre-camp materials: social story, visual schedule, and special camper pack to prepare each child
- High-quality resources and activity options tailored to each camper's therapy goals
- Post-camp summary highlighting the child's experiences and progress

### **Why Do We Have to Pay a Private Amount?**

NDIS funding only covers specific hours of therapy. Any time outside formal therapy (e.g. overnight care, food, and some admin costs) must be covered by a private amount. This ensures we can deliver a high-quality, well-resourced camp with the right staffing and support, while ensuring we are able to access therapy funding.

### **Payment Timeline:**

\$100 private payment required at time of booking to secure place

↓

If unpaid, child's place will be forfeited and offered to someone else

↓

Planning costs invoiced via NDIS prior to camp

↓

Remaining camp charges invoiced following the camp

### **Cancellation Policy:**

- The private payment is non-refundable.
- The NDIS portion follows a 7-day cancellation policy. Cancellations made less than 7 days prior will incur a full late cancellation fee.

### **Booking and Invoices:**

#### **PRIVATE**

- The \$100 private payment is paid through our booking platform. This link is sent after Rosewood receives the initial booking interest form and assesses the client's suitability for the camp.

#### **NDIS**

- Rosewood will invoice planning and preparation time prior to camp. All remaining therapy hours from the camp will be invoiced following the camp's completion.
- Rosewood can provide services for Plan Managed and Self Managed NDIS participants. We are not able to accept NDIA-managed clients at this time.
- The NDIS portion follows a 7-day cancellation policy. Cancellations made less than 7 days prior will incur a full late cancellation fee.
